All Posts are required to revalidate annually by 21 May with Dept of Florida. See revalidation checklist at end of the document. Validate with National online at WWW.AMVETS.ORG. You must sign in using your membership number and email on record. You must already be listed in the Post validation wizard to access the Post validation Module. Send an email with your current 990 and Insurance Acord25 to National at membersupport@amvets.org to be updated on the validation page (note: Ensure the current address is listed in the Certificate Holder on the Accord25 for National). Click on Post revalidation and fill in all blocks on all three pages. If you do not check one of the boxes on the last page concerning the CBLs, it will not be sent forward and the validation will not complete. Once you get confirmation, an email will automatically be sent to the Dept of Florida Executive Director, no further action required. To Validate with the Dept of Florida, fill out DOF re-validation form located at WWW.AMVETSFL.ORG. listing all officers and send to the Department Executive Director along with your Sunbiz Articles of Incorporation (do not update your AOI until after the May elections), Insurance Acord25, front page of most current 990 or 8868 extension

This will allow National to update their validation page with the current date. If you don't have it, you can get it at the IRS website using your EIN#, cntr+click on link to go to IRS Search site:

3.4. Send validation sheet to Executive Director provided to each post and can be downloaded from the DOF website at www.amvetsfl.org.

3.5. Lastly, by July 15th revalidate with National by going to their website. You must already be listed on the validation module to be able to access the Post Validation menu when you log in using your email and member number (or Password). If not complete by this date, you will be locked out and will have to contact National to be able to do this.

Note: If you validate with National you are telling them that all documents have been filed with your Department and that the Post is in good standing with all documents.

NOTE: Revalidation is very Important and failure to do so by August 1st can result in your Post Charter being suspended. What that means is you lock your doors until it is done. Any questions or problems contact your Executive Director
